## Entry requirements

Countries in the itinerary of the World Cruise 2024 which require a visa:

For some destinations, usually subject to the visa requirement, there are exemptions for this cruise:

COUNTRY OF ORIGIN	COUNTRY
Austria, Switzerland, Germany, Denmark, Spain, Portugal, France, Italy, Norway, Belgium, Holland and Poland	<b>Barbados:</b> no visa is required for a stay of less than 24 hours.
As above	<b>Japan:</b> visa exemption is available on condition that the duration of stay does not exceed 90 days.
As above	<b>Oman:</b> no visa required. A shore leave permit is issued directly on board for stays not exceeding 48 hours.
As above	<b>Papua New Guinea:</b> no visa required. A shore leave permit is issued directly on board by immigration.
As above	<b>Vanuatu:</b> tourist visa is issued upon arrival in the country.
Austria and Switzerland, Belgium, Poland, Portugal and the Netherlands	<b>Vietnam:</b> transit visa is issued on arrival. The cost of USD 10 will be charged to the on-board account.
Germany, Denmark, Spain, France, Italy, Norway	<b>Vietnam:</b> no visa required.

Regarding entry requirements for other nationalities, it will be necessary to check the specific rules applied by each country included in the itinerary according to nationality, as different requirements may apply. We will be happy to provide the necessary information on request.



## Travel document required

An electronically readable passport, that must be valid for at least 6 months after the end of cruise. We also recommend having at least 10 blank pages for applying stamps when entering and leaving countries. If you have citizenship different from those indicated above, you should contact the relevant consulate. All the countries in the itinerary of the World Cruise must be considered individually.



## Covid-19: information on vaccine status and on testing

**Who can come on board?** Anyone, regardless of vaccination status.

**Are tests foreseen?** No, they are not planned, neither before embarkation nor during the cruise.

**As a general rule, it is advisable that the passengers of the World Cruise 2024 bring with them their own complete vaccination certificates for Covid-19.**

**Medicines:** it is important to ensure that you carry all the necessary medicines to cover the entire duration of the cruise, considering that the places visited may have different or poorly organised health systems where not all medicines and dosages are available.

**It is strongly recommended to take out travel health insurance (including Covid-19 cover), which covers all of the countries included in the itinerary for the period of the cruise.**



## Arrivals and departures

For those who have a flight, it is recommended to reach the airport **at least 3 hours before the departure** of the flight to account for possible delays and disruptions.



## Regulation on luggage for flights booked through Costa

Exclusively for this cruise you will be able to take **2 pieces of luggage free of charge**. We take on the additional costs. This applies to **any airline**.



## Upgrade of beverage package

Drinks at the table are already included. On board, the Guest will have the possibility of booking an 18 €/day per person **MyDrinks package**.



## Laundry service

During the World Cruise, the **'Magic Bag'** laundry service will be offered several times. The service in which we bring washed and folded laundry directly to the cabin at a particularly favourable price! Further details will be available on board.
